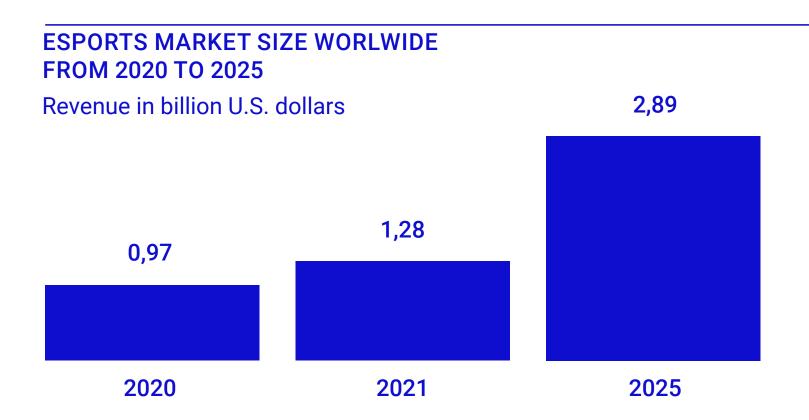

# 1. INTRO

According to market statistics, the revenue of the global eSports market is estimated to have tripled in less than a decade. Not only does this make the industry lucrative for investors, but also the fact that the industry is a completely new economic concept.

Yet in many aspects, similar to the traditional sports market, the eSports market still suffers from significant limitations due to multiple bottlenecks.



Many of the limitations that prevent participants from joining the growing market can be considered artificially created by several clusters controlling the cash flow of the entire industry.

We at EverGaming have designed a new paradigm for the eSports economy and we are developing a platform to decentralize the market.



#### 1. Intro

Our main idea is that every entity on our platform will be framed as a DAO. We will tokenize each participant of our ecosystem.

Each entity – streamer/influencer, team, organiser, player – will have its own tokens and its own content. They will be able to build their own economics and tokenomics. Teams can fundraise, they can sell their own NFTs and viewers can donate tokens to their favorite streamers.

Right now the eSports market is vastly centralised around several major participants, such as tournament organisers and streaming platforms, that receive the lion's share of profits. The downside to this kind of financial distribution is that most of the budget is currently spent on marketing and promotion, with little to no resources directed towards industry growth. It is surprising that in such a diverse, global, and highly technological market as eSports, growth for most gamers and content creators is hardly possible without substantial support from big players.

We are going to launch an ecosystem with modern mechanics that will balance the eSports market and allow it to grow exponentially and scale out to much larger audiences.

#### 1. Intro

#### Mobile gaming as a primary focus

We find it crucial to designate the markets where the impact of EverGaming will be most effective for the project development and for the industry itself.

The recent years have made it obvious it is the mobile gaming market that is still remaining in its initial stage, has a huge growth potential and has never received substantial investment to organise into an ecosystem with its own Esports environment.

EverGaming in the next several years will primarily focus on democratising and making mobile gaming competitive and lucrative for those seeking a professional career, advertisement and audience.

During the projected period, the worldwide market for mobile gaming is expected to rise due to the rising adoption of smartphones and the trend toward gaming technology.

Due to the rising popularity of cutting-edge platforms like Facebook and Instagram, the mobile gaming business is anticipated to expand to larger international communities.

With more indie and mainstream titles released every year, the broad selection of games is anticipated to boost the entire mobile gaming business.



#### 1. Intro

The whole mobile gaming sector is probably going to profit from the expanding urban population and increased disposable income.

One of the major factors fueling the expansion of the mobile gaming business is the popularity of multiplayer games. Online games are continually being created to stray from traditional gaming.

Gaming and computers are closely related. In this instance, the phone has become more than simply a straightforward communications tool. A new generation of multifunctional gadgets that can process speech, text, and video data was introduced by the smartphone.

People use phones, which are essentially little computers, in the information and digital age. It has evolved into the perfect platform for video games as well.

According to Statista projections for 2022, there are already 6.5 billion smartphone users globally, and that number is expected to rise. A sizable portion of the proportion is made up of players on mobile devices.

The statistics of 2022 show there are around 2.5 billion mobile gamers worldwide, which is comparable to the number of PC and console gamers combined.

2. ESPORTS MARKET PARTICIPANTS

Sponsorship, advertising, merchandising and tickets, publisher fees, and media rights are the different revenue streams in the esports business. By income source, the sponsorship sector was the largest segment of the esports market in 2020, accounting for 61.2 percent of the total. In a market that has been split by platform, the advertising segment is predicted to develop at the quickest rate in the esports industry.

With a huge number of minor players, the esports market is highly fragmented. In 2020, the top 10 competitors accounted for 69.0 percent of the overall market. This could be owing to the fact that the market has a lot of local companies serving customers in certain areas.

The main financial flows are currently divided between the following market entities.

**Gamers** – The player's prize money and income from streaming activities do not depend on the esports organisation. But salaries, as in any big sport, are paid by the respective clubs. They are formed from income generated from partnership contracts and investors' money. If their cyber athletes are successful, a club will be able to generate income for investors.

**Content creators** – Content creators' income is built from paid subscriptions, donations, and, of course, ad integrations, which are at the top of this list.

Advertisement & Marketing – Major global brands have been interested in streaming capabilities for some time now. Red Bull, Mercedes-Benz, Old Spice, L'Oreal, MAC, Coca-Cola, and many others use streaming platforms to integrate their products. The main advantage is the ability to reach a wide variety of audiences that are not accessible via conventional display advertising.

Media Organizations – The main source of income for organisations is the fees they charge on transactions between users on the marketplace. At the same time, one of the most important channels of income is the sale of games and in-game valuables. Companies also make a profit by selling tournament organisation rights to third parties. When they organise tournaments on their own, companies profit from ticket sales, broadcasts, and merchandise, as well as advertising agreements.

**Game Developers** – Developers mainly generate their income through the sale of their products. There are various ways of making a profit, such as: selling a game, seasonal pass, subscription, or various in-game values and loot boxes.

**Esports organizations** – eSports organisations act in the same way as traditional sports leagues: they develop sponsorships, implement media rights, and earn on advertising inventory, tickets, paraphernalia, and licensed products.



Despite the remarkable growth that has occurred in the industry and all the upside it presents to investors and market participants, there are still a number of issues:



#### No gaming events on demand

No need to search for tournaments starts. You can find them instantly. Gamers and content creators instead have to hunt and lurk for tournaments with no fixed prize systems, while advertisers had no platform to connect them with their target audience directly.

The currently existing market solutions are single faceted and not complex, mainly offering tournaments as the only type of event making (No all-in-one on-demand service existing).



#### Market monopoly

Most revenues are obtained by the middle-men: advertising agencies, tournament organizers, streaming platforms, making it impossible to scale up in the gaming industry.

The existing platforms and services work against decentralization to prevent the mass crowd of value creators from receiving major profits.



#### Inertness of mobile gaming

Mobile apps and games only support the function of buying in-game items with no real mechanics of monetizing your skill and time.

Mobile gaming is overtaking the PC gaming market by several times in terms of growth.

The offer of sponsors is constantly growing, more and more brands want to get access to a mobile audience.

#### 3 OUT OF 5 GAMERS ARE GENUINELY DETERRED FROM GAMES THAT ENCOURAGE IN-APP PURCHASES AND PAY-TO-WIN MECHANICS

Based on the information provided above about the sources of income for market participants, we can safely conclude that this niche is not friendly for new players, developers, young organisations, and other teams starting their journey.

As you can see, in almost every sector of esports, one of the main sources of revenue is advertising and sponsorship. Large organisations have long had this kind of agreement with leading brands in the global market.

Obviously, in such an environment, it is difficult for new players and teams not yet known to find their place and establish mutually beneficial partnerships, because without having an extensive fan base or a large number of viewers on streams, you are not have a lot of advertising interest directed your way. Thus, new market participants lose out on one of the main channels for making a profit, a fact which entails a decrease in competitiveness and a slowdown in the development of the esports sphere as a whole.

An important factor in the popularisation of eSports is tournaments held by game developers or companies that have bought tournament rights. But at the same time, tournament participants are invited directly by tournament organisers, which is why teams that are already widely known and popular in their regions receive invites because the main source of income for the organisers is the sale of tickets, broadcasts, and advertising.



Faced with choosing between a young but strong team and a weak team with a huge fan base, organisers will inevitably choose in favour of the latter, which is understandable because they care about attendance, visibility, and merchandise sales, and not the sports component of the tournament, which in turn complicates the development of new eSports organisations.

It should be noted that starting a career as a streamer is also not easy. Without a fan base as a professional gamer, it is very difficult to gain the following necessary to generate interest from advertising partners and investors. At the moment, this niche has a huge chasm between new and successful streamers. It would seem that a lack of investment and advertising contracts can neutralise the collection of donations and support from the audience, but there are also some nuances here. At the very first stage, when you are just starting your journey, it is very difficult to find regular viewers and increase their number. This is a very long and painstaking process.

Streaming platforms have a number of limitations and difficulties for new members, from an inability to choose the quality for the viewer to the lack of any kind of support. There is a complete lack of assistance in promotion and development for newcomers. Also, not everything is so smooth with donations. Third-party services that allow fundraising take a commission and do not contribute to the development of new channels in any way.

As is clearly visible, the current market system centralises economic power in the hands of big corporations that organise the most popular events and advertising businesses that reach out to eSports and gamers audiences. We believe it is possible to establish straighter and fairer cash flow systems with the use of blockchain

and crypto: cryptocurrency and tokenization can be used to bring DeFi to a rapidly growing market.

#### No place for mobile tournaments

At the same time, we can see there is no tool or system to provide a solution for competitive or challenge-based scoring, no place to arrange and monitor tournaments, and no space for gamers, content creators and sponsors to directly interact.

While the overall Esports industry is struggling over issues of unfair financial distribution and monopoly, mobile gaming competitive sports is experiencing even worse: big market players do not seek an opportunity to develop, while many talents are restricted from their future careers without the financial support.

### **EVERGAMING SOLUTION**

Our solution for the market is to develop an advanced environment for the eSports industry that can decentralise control and lower the entrance threshold for millions of talents.

The main conceptual standout of Esports DAO is our plan to make one token the core of the entire market. In order to do so, we present our multi-dimensional platform for eSports tournament management, team support, content creation monetization, and more - all to be fueled with the EVG Token.

EverGaming is the perfect environment to support the growth of the mobile gaming tournament and competition sports: all the actors of the industry are unable to survive without such an intersection.

By providing \*Stable token\* We offer everyone a perfect tool for quick and cheap cross-border transactions that will work perfectly for the gaming industry, where transaction speed, security and fee size are the core criteria - and only a state-of-the-art blockchain can provide in full scale.

At the same time we aim to revolutionise the market by making EverGaming a space where anyone can grow and earn by helping the gaming and tournament industry grow. EVG is a tool that allows every possible entity to tokenize their activity as a business and grow. You can create your team, receive crowdfunding support, issue and sell your own Team Tokens and share your success with your backers.

As a content creator, you have a toolbox for managing your events, selling access and sharing rights and responsibilities with your contractors - that is made reliable and immutable with the help of the blockchain technology.

Finally, EverGaming is a project to help many other projects launch and grow, so we believe in mutual growth. The DAO Foundation will support the financial growth of the ecosystem by helping the EVG price grow. With more profits being received EverGaming DAO will vote to allocate up to 50% of profits to acquire some portions of EVG from the free-float regularly depending on the circulating supply volume and price. This way EverGaming DAO will ensure the ecosystem can continue to develop and early adopters can win from their participation in the early phase.

With the benefits of DAO in decentralisation, members of an organisation may speak up for the future of the organisation. Each EVG holder has certain rights that allow them to influence the organisation's direction. The DAO is capable of introducing unique advances with the help of potential contributions from several individuals.

Speaking of community engagement, another significant mention among DAO benefits is each member's active stake. The processes behind the DAO are primarily concerned with allowing members to exercise their ownership in the organisation. To begin with, EVG DAO governance tokens suggest that the tokens must be acquired and locked or burnt in order to obtain voting rights. As a result, members are more inclined to vote carefully and thoughtfully. In other words, governance tokens on DAOs enable all users to influence the destiny of EverGaming and the entire industry.

Tournament organizers can easily split events according to team ratings, e.g. A, B and C leagues.

With EVG, users will be able to find an all-in-one platform for becoming an independent and developing part of the Esports market.

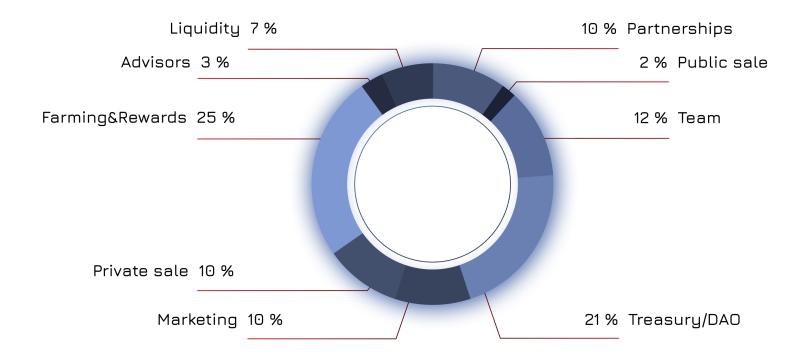
### **EVERGAMING FOUNDATION**

In order to ensure our goals are achieved and the EverGaming ecosystem develops into a healthy and growing community-driven market, the EverGaming Foundation, consisting of technical experts, including our partners from the Everscale Alliance and our project's advisors, will operate as an entity within the EVG environment.

The goal of the Foundation is to support growth initiatives, help communities and service providers integrate and more. In the early stages of ecosystem establishment, the Foundation will also assist EVG ecosystem participants establish new partnerships; the Foundation will gather feedback from users of all levels and help our team prioritise the necessary toolset development.

Since decision-making at EverGaming is decentralised and customer-centric, the Foundation will receive a limited amount of EVG tokens, hence it will be gradually driven into remaining an authority within the market and not above it. With the growth of the ecosystem, the EverGaming Foundation will focus on ensuring the DAO governance principles within our market.

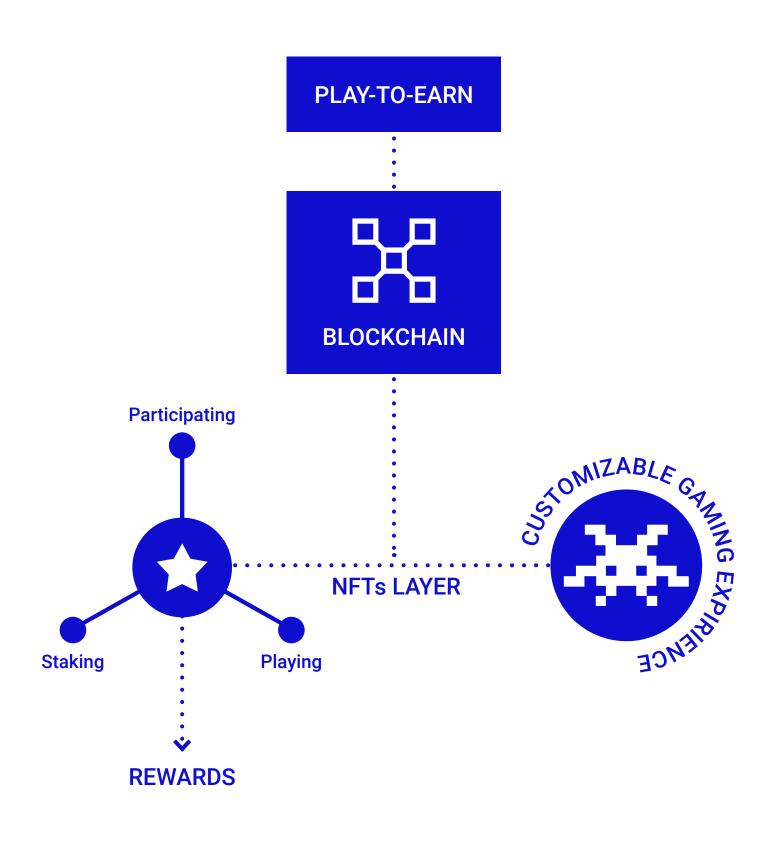

The current situation in the Esports market is one of stagnation, with many potential new participants restricted from entering thanks to large audience acquisition costs and substantial fees implied by several layers of financial institutions, such as sponsorship programs, money transfer and acquiring systems, advertising agencies and more.

Blockchain is a technology that offers a new structure of financial interaction: content creators can directly capitalize on their performance and use the benefits of a transparent customerdriven market.

With blockchain, every type of market interaction can become a digital asset: not only can a fan support their team with donations, but entire communities can organise events, play tournaments, advertise, create and sign contracts, produce and distribute merchandise and establish NFT copyrights, all within one platform.

### **EVG MARKET VALUE**

is based on several core factors, both financial and utility:

#### Limited and decreasing supply

The DAO will mint only 20 MLN EVG tokens at the genesis. Moreover, a specific part of the revenue (50%) will be permanently burned upon distribution, gradually reducing the token's total supply and making it more valuable.

#### **Continuously growing demand**

The platform earns a small fee on all types of transactions made through it: tickets and subscriptions sales, prize funds, crowdfunding, marketplace sales, gambling rakes, etc. This way we increase the EVG circulation rates but prevent market inflation.

#### **Utility function**

It will be possible to make purchases, donations, and engage in gambling using EVG tokens, making it more liquid and giving it a utility function. With this, the free float of EVG tokens will also reduce as the tokens will stay longer within the platform instead of going to the DEX.

#### Token lock

According to the duration and amount of staking, EVG staking will distribute the accumulated revenues among all stakeholders. Alternatively, an investor can supply the EVG pool on the DEX and participate in the yield farming programs.

We aim to stimulate investors to lock their EVG funds into the platform for as long as possible, reducing the free float and creating positive pressure on the token price.

It's also worth mentioning that all payouts will be gradually vested for a few weeks to prevent the immediate spillage of gained tokens into the market.



EverGaming is more than just another platform to buy and spend crypto: the revolutionary part of our design is the platform's DAO management approach. Instead of stagnating in the bottlenecks of a centralized market, we are introducing a paradigm where the customers and creators have distributed control of the ecosystem growth and development, helping them increase their returns and benefits.

This will make this kind of model more attractive to the user and will also attract more new participants and investors to young developing projects.

EverGaming will support non-custodial staking services beginning with Everscale and Binance Smart Chain ecosystem assets.

EVG is the native coin of the EverGaming platform, built on Everscale blockchain.

Our main mission is mass adoption. We are making a user friendly interface that everyone can use easily. For easy entry, we will pay special attention to payment providers and fiatcrypto gateways.

### **DAO PRINCIPLES EXPLAINED**

The question of how to control decentralized protocols becomes gradually more and more important with the DeFi and NFT communities growing in number. One of the most obvious issues facing these communities now, and in the coming years, is figuring out governance – the act of managing communal decision-making in order to maximize revenues and operations.

However, governance incurs high coordination costs as a result of the requirement for network participants to vote on every decision made. In emerging decentralized networks, where smart contracts empower users to rule collaboratively, these coordination costs can be drastically reduced.

These new community-based networks are known as Decentralized Autonomous Organizations (DAOs), and they are made up of people who align incentives and similar interests, operate nearly entirely by code, and have no one leader or single point of failure. In development, much of the effort so far has

been focused on open-finance-based systems. In many ways, DAOs resemble a jumble of investment banks, corporations, and social clubs, all of which are linked by cryptographic agreements.

However, bank systems in recent years have given way to more futuristic open-finance platforms and tools, introducing the trend of Decentralized Finance (DeFi). New DAOs began to appear, at that point designed with financial incentives to encourage membership in these systems: without such, network members would have no motive to invest their effort, money or time in networks, vote on proposals to improve them, or care about their future expansion and success.

When the governance burden associated with curation, security, and risk can be decreased quicker than the inevitable increase in coordination costs that come with the need for members to vote on every decision made, DAOs operate best. DAOs leverage blockchain technology and programmable incentives to address difficulties that global businesses have traditionally faced, such as financial transparency, process automation, governance, and aligning geographically dispersed, individual stakeholders around a shared purpose.

When creating the concept design of EverGaming, we kept in mind that the platform would have to serve the needs of service providers, content creators and audiences internationally and for every level of customer: we needed to implement a market paradigm where communities could be created, managed and sponsored and where users would be able to direct future development.

EverGaming is an ecosystem that is being developed around a decentralized governance structure, in which every involved user

has the opportunity to participate in community based voting.

DAO's are a paradigm shift in the very idea of economic organizations, offering complete transparency, total tokenholder control, unprecedented flexibility, and autonomous governance.

This platform will be a decentralized, censorship-free ecosystem without intermediaries, where gamers, event managers, influencers, and viewers involve and interact closely and use an end-to-end DAO to build a self-sustaining community beneficial for each member.

A DAO is a decision-making system without intermediaries. All decisions are made directly by the participants in this ecosystem.

The most important thing is that there are no indifferent people in the system, all participants are interested in growth and development. A DAO is a community-governed organization, where everything is clean and transparent.

DAOs are the next trend with huge potential. The segment is just forming. All crypto projects without a transparent working real DAO will be outsiders.

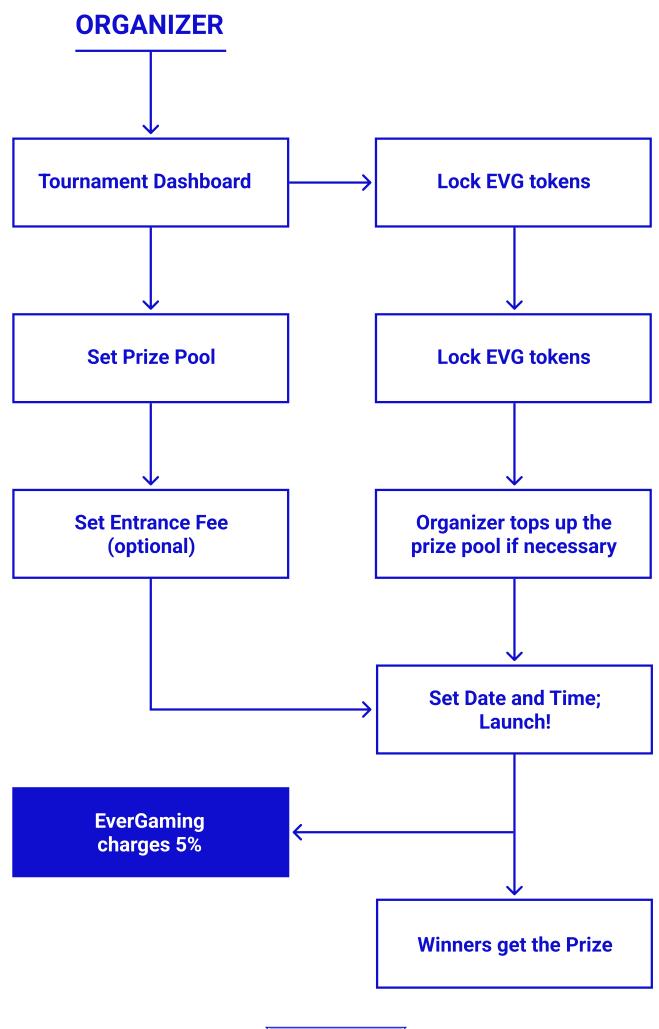
### TOURNAMENTS

We also encourage tournament organizers to receive additional rewards from advertisers: placing ads on the tournament page allows for direct interaction between value creators and publishers.

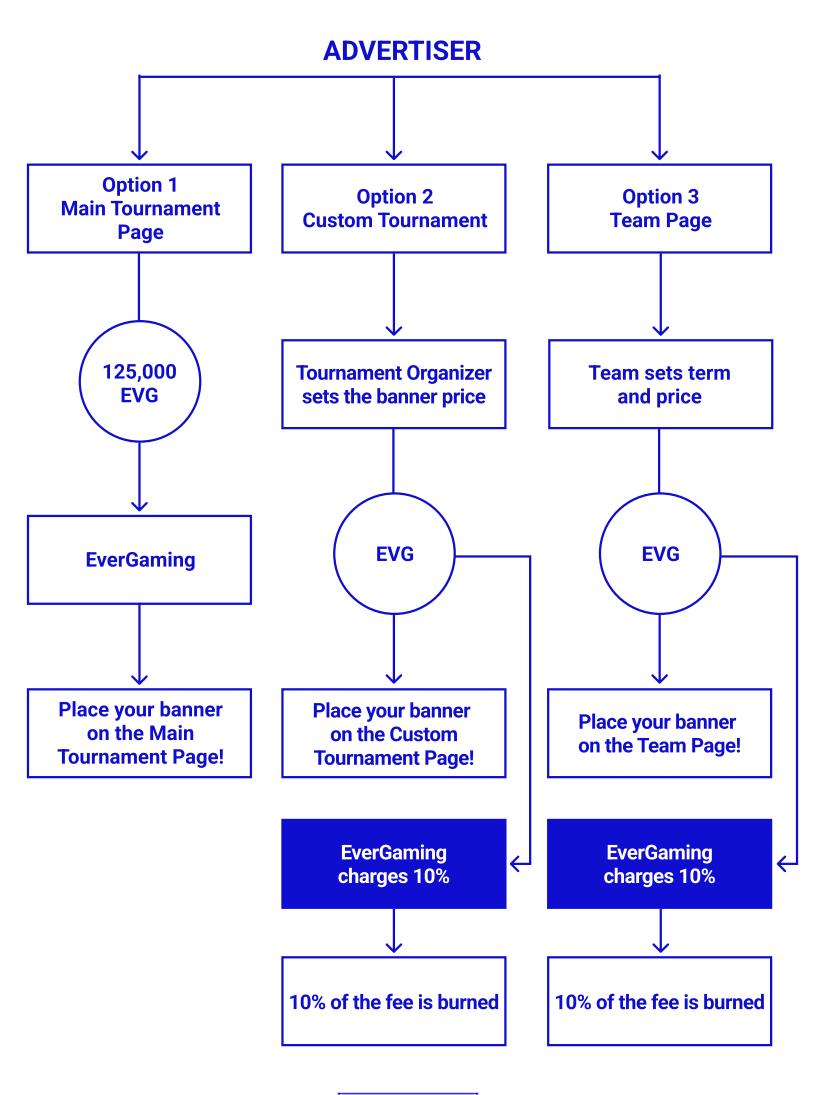
Additionally every organizer can invite broadcasters to highlight the tournament, so that it receives more views and followers.

Currently the market revolves around the biggest players receiving major profits from advertising, with little reward reaching the real value makers. Now it seems impossible for an average talent to monetize on gaming tournaments without being consumed by some of the worlds biggest tournament organizations; at the same time playing in the big league does not guarantee the quality of content, while a majority of great talents remain barely floating with little to no income and seldom donations from their fanbase. We believe the gaming industry will only benefit from becoming reachable by the mass crowd.

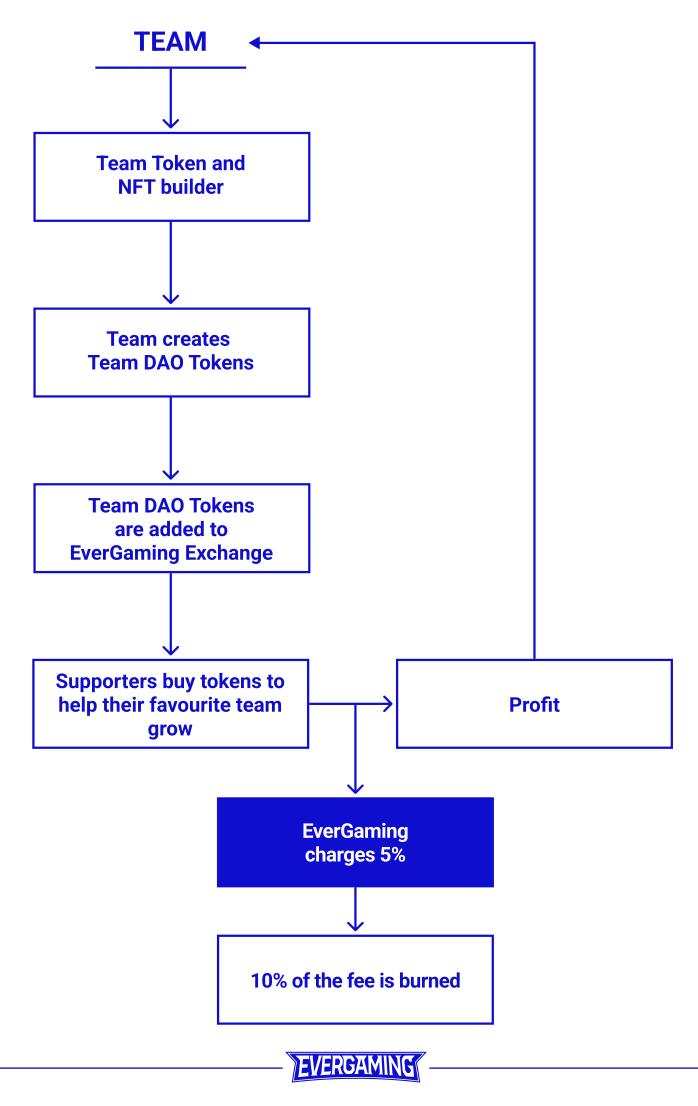

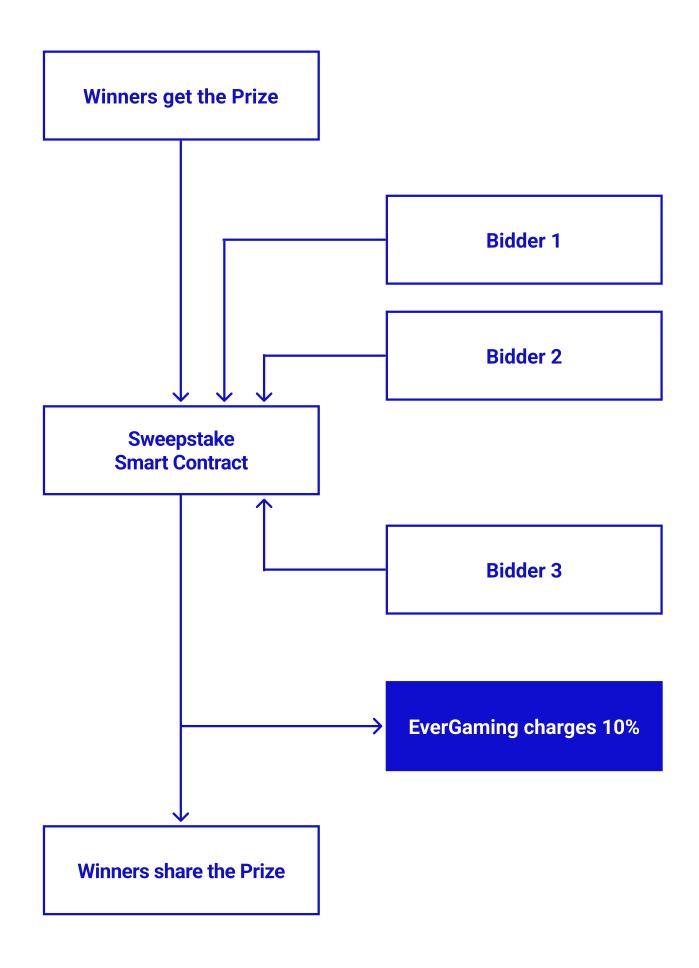

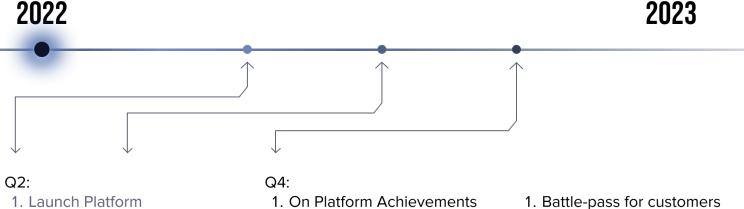
